- No work is to begin unless a permit has been issued.
- Private sewage designs and installations within Rocky View County are required to meet the criteria in Rocky View County's Policy #449 - Requirements for Wastewater Treatment Systems.
- Some Subdivisions and Direct Control Districts have specific design and installation requirements. Please ensure you are familiar with any requirements for your area.
- The installation of Private Sewage Systems in Rocky View County must be completed by a certified private sewage installer and must meet the requirements of the Safety Codes Act. Homeowner Installations are not accepted.
- Private sewage design submissions and works are inspected by an inspection service company on behalf of Rocky View County.
- Private sewage fees paid to Rocky View County include one design review and one site inspection. Please review the information documents: *Inspection Requirements* available at: www.rockyview.ca/inspections
- The inspection service company may issue 'extra fee notices' to be paid for:
 - work not ready at time of scheduled inspection,
 - o no access at time of scheduled inspection,
 - additional inspections due to project complexity,
 - o failure of an inspection (requiring a return inspection).

All extra fees are to be paid in full before subsequent inspections can be scheduled.

- All fees (including extra inspection fee notices, issued by the inspection service company) are to be paid to Rocky View County.
 Please refer to our website: www.rockyview.ca/BuildingPlanning/BuildingPermits/Fees for current fee rates and payment options.
- All permits expire one year from the date of issuance. Extensions to the permit expiration date can be requested from Rocky View County Building Services in writing, before the expiration date. If the permit expires, renewal fees will apply to reactivate / renew the permit(s).

Once a permit has been issued, the permit holder(s) is responsible for:

- Complying with the terms and conditions of the permit. Please ensure the permit conditions are reviewed thoroughly.
- Ensuring that all required inspections are booked and finalized with no outstanding deficiencies before the permit expiry.
- Notifying the permit issuer if:
 - there is a change in ownership and/ or contractor from what was submitted on the permit applications,(a permit is not transferable to any other person unless the transfer is authorized in writing by the permit issuer).
