The Development Permit application for Animal Health (Inclusive) (existing), relaxation to the maximum fence height requirement has been **conditionally-approved** by the Development Officer subject to the listed conditions below (**PLEASE READ ALL CONDITIONS**):

# **Description:**

- 1. That the construction of an over-height fence may commence on the subject lands, in accordance with the submitted application site plan, as amended to meet conditions of this approval and includes:
  - i. That two galvanized mesh fence enclosures, up to **2.44 m (8.00 ft.)** in height, may be installed for the subject outside storage area, per the submitted application site plan.

#### Permanent:

- 2. That any plan, technical submission, agreement, matter, or understanding submitted and approved as part of the application, shall be implemented and adhered to in perpetuity.
- 3. That if the fence is not maintained to the satisfaction of the Development Authority, it shall be required to be repaired or removed.
- 4. That the fence shall not be expanded or enlarged at any time unless approved by a separate Development Permit.

## Advisory:

- That the County's *Nuisance and Unsightly Property Bylaw C-7690-2017* shall be adhered to in perpetuity.
- That the site shall remain free of Regulated, Prohibited Noxious or Noxious weeds and the site shall be maintained in accordance with the *Alberta Weed Control Act [Statutes of Alberta, 2008 Chapter W-5.1; Current as of December 7, 2023].*
- That any other federal, provincial, or County permits, approvals, and/or compliances, are the sole responsibility of the Applicant/Owner.
