

**MUNICIPAL DISTRICT OF ROCKY VIEW NO. 44
BYLAW C-5298-2000**

A Bylaw of the Municipal District of Rocky View No. 44 in the Province of Alberta respecting the boundaries of electoral wards or divisions for the Municipality.

WHEREAS pursuant to Section 3 of the Municipal Government Act, S.A., 1994, c. M-26.1 and amendments thereto (the "Municipal Government Act"), the purposes of a Municipality include good government; and

WHEREAS pursuant to section 148 of the Municipal Government Act, Council may by bylaw divide the Municipality into wards ("divisions") and establish their boundaries, and, give each division established a name or number or both; and

WHEREAS the Municipal District of Rocky View No. 44 desires to change the boundaries of the nine (9) electoral divisions in order that the population for each revised division is closer to the average population per division of 3,160 determined by dividing the 2000 official figure of 28,441 by 9 divisions; and

WHEREAS a Bylaw passed under Section 148 must be passed at least 180 days before the general election at which it is to take effect; and

WHEREAS the Municipal District of Rocky View No. 44 desires to have the divisional boundaries adjusted in order that they are in effect for the general election in October, 2001;

NOW THEREFORE the Council enacts the following:

1. The Boundaries of the Divisions shall now be:

3. The population based on the 2000 census for each of the nine (9) revised divisions is as shown in the table attached as Schedule B, and
4. The divisional boundary adjustments are to take effect for the general election to be held in October, 2001.
5. This Bylaw shall come into effect upon third and final reading.

Second reading passed in open Council, assembled in the City of Calgary, in the Province of Alberta this 18th day of April, 2001 on a motion by Councillor Stinson.

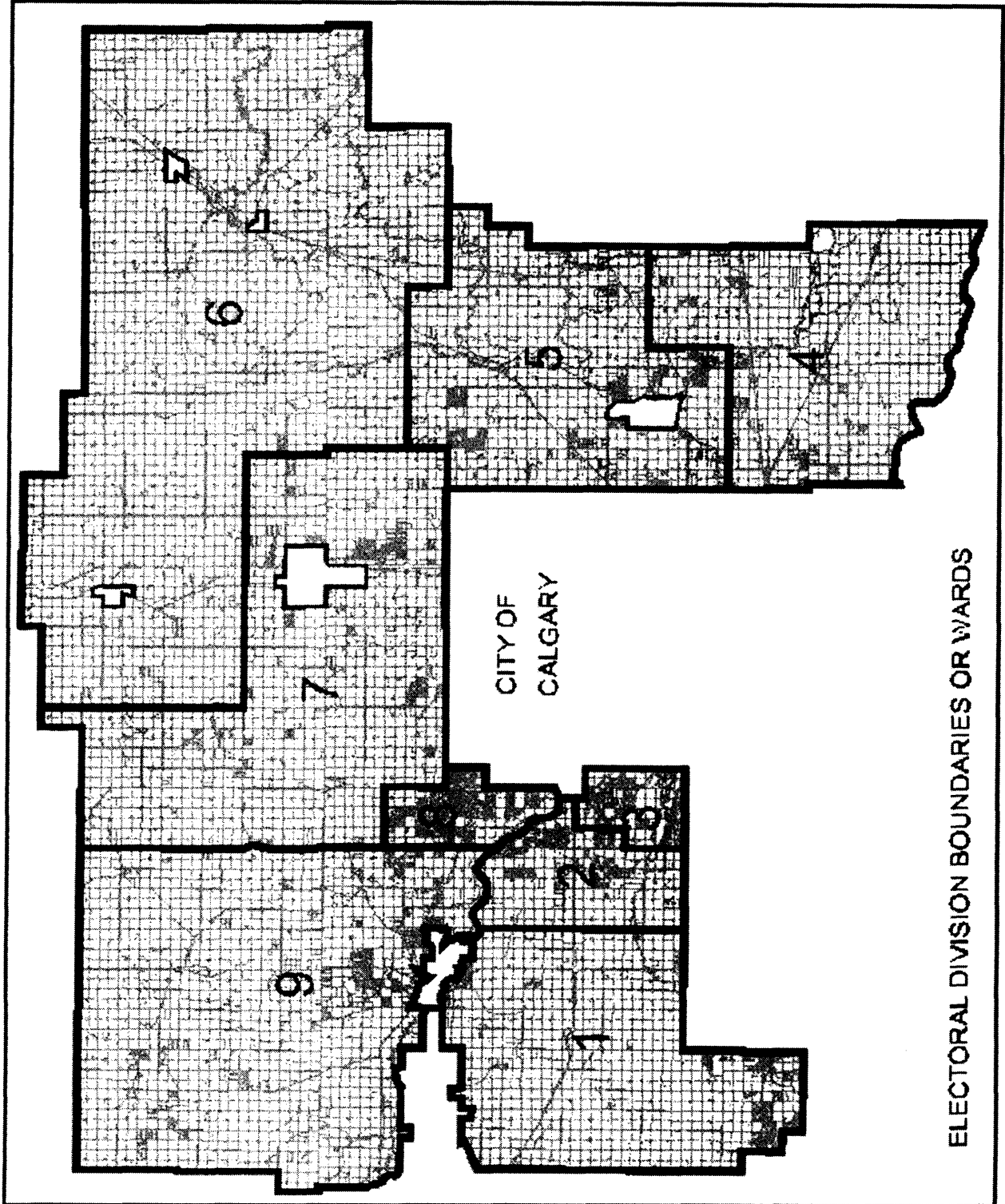
