That an election will be held for the election of a Senate nominee for the purposes of the *Alberta Senate Election Act*;

That a vote of the electors will be held on the following referendum questions under the *Referendum Act*;

- Should Section 36(2) of the *Constitution Act, 1982* — Parliament and the government of Canada's commitment to the principle of making equalization payments — be removed from the Constitution?
- Do you want Alberta to adopt year-round Daylight Saving Time, which is summer hours, eliminating the need to change our clocks twice a year?

All voters must provide identification to confirm their identity. ONE of the following documents must be presented to the Deputy Returning Officer at the time of voting which includes the elector's NAME and ADDRESS. Picture ID is not required.

Government issued identification (federal, provincial, local or agency) that shows the elector's name, address and photo of the elector; government cheque or cheque stub; income/property tax assessment notice; statement of government benefits (e.g. employment insurance, old-age security, social assistance, disability support or child tax benefits); correspondence issued by a school, college or university; bank/credit card statement or personal cheque; insurance policy or coverage card; letter from a public curator, public guardian or public trustee; pension plan statement of benefits, contributions or participation; residential lease or mortgage statement; utility bill (e.g. telephone, public utilities commission, television, hydro (electric), gas or water); vehicle ownership, registration or insurance certificate; or a letter or form (attestation) confirming that the person lives at the stated address.

As required by section 53 of the *Local Authorities Election Act*.
