  - a. Pre-recorded presentations can be no longer than 5 minutes if you are speaking on behalf of yourself and 5 minutes if you are speaking on behalf of a group.

The video or audio presentation must include your name and the municipality in which you live, and if you are speaking on behalf of a group you must also provide the names and municipalities of the people you are speaking on behalf of.
