#### **A BYLAW C-8139-2021**

**DIVISION 4** – Public hearing to consider Bylaw C-8139-2021 to close a ± 1.58 hectare (3.91 acre) portion of road allowance between SE-9-28-5-W5M and SW-10-28-5-W5M, and to consolidate equally between the eastern and western parcels. Located south of Grand Valley Road, between SE-9-28-5-W5M and SW-10-28-5-W5M, and approximately 0.35 km (0.22 miles) west of Grand Valley Road.

#### **B BYLAW C-8317-2022 AND C-8318-2022**

##### **DIVISION 5**

PL20220032 - Public hearing to consider Bylaw C-8317-2022 to amend the Balzac Commercial Campus Conceptual Scheme:

- Remove the requirement that the road system has been constructed and received a Construction Completion Certificate prior to a Development Permit being issued.
- Remove setback and site coverage requirements for buildings abutting Highway 566;
- Revise the policies requiring suitable building facade treatments, visual screening, and landscaping buffering facing Highway 566.

PL20220033 - Public hearing to consider Bylaw C-8318-2022 to amend Direct Control Bylaw C-6031-2005 (DC-99):

- Reduce the minimum required width of landscaped buffer facing Highway 566 from 10 m to 9 m;
- Increase the maximum building height in Cell A from 10 m to 15 m;
- Increase the maximum site coverage in Cell A from 25% to 48%;
- Include the subject lands into the area that is allowed for a maximum site coverage of 55%.

Located approximately 0.81 km (0.50 miles) west of Range Road 292 and on the south side of Highway 566.

#### **C BYLAW C-8299-2022**

**DIVISION 6** – Public hearing to consider Bylaw C-8299-2022 to redesignate ±63.60 hectares (±157.16 acres) within N1/2-19-23-27-W04M from Agricultural, General District (A-GEN) to Special, Future Urban Development District (S-FUD) to allow storage of large earth moving equipment. Located approximately 2.41 km (1.50 miles) southeast of the city of Chestermere on the southeast corner of Highway 560 and Highway 791.

## **D BYLAW C-8287-2022**

**DIVISION 5** – Public hearing to consider Bylaw C-8287-2022 to redesignate the subject ±35.30 hectare (±87.52 acre) parcel, being the remainder of the north ½ of fractional Section 10-28-29-W04M, from Agricultural, General District (A-GEN) to Direct Control District (DC) to allow for the future subdivision of one ±17.81 hectares (±44.01 acres) parcel and the future development of a Solar Farm, Electric Vehicle Charging Station, Electric Storage System, and Electronic Data Processing on that parcel, thereby leaving a ±17.49 hectare (±43.22 acre) DC District parcel. The proposed balance parcel would also have the same uses of Solar Farm, Electric Vehicle Charging Station, and Data Processing uses available. Located approximately 3.2 km (1.99 miles) southeast of the town of Crossfield, on the southeast junction of Highway 2 and Highway 72 (Township Road 282).
