Public hearing to consider Bylaw C-8460-2024 to redesignate the subject lands from Agricultural, General District (A-GEN) to a Direct Control District (DC) within SW-19-25-02-W5M and a portion of SE-19-25-02-W5M to facilitate residential and commercial uses, as detailed in the approved Ascension Conceptual Scheme. Located approximately 1.61 kilometres (1.00 mile) north of Township Road 252 on the west side of 12 Mile Coulee Road.

 - a. Written submissions must be received by the deadline indicated on this notice. Written submissions received after the indicated deadline will be accepted by Rocky View County and may be provided to Council as part of the Public Hearing, if approved through a resolution of Council.
