#### **DIVISION 3**

Public hearing to consider Bylaw C-8506-2024 to create a site-specific amendment to the Direct Control Bylaw C-6586-2007 (DC-123) to allow the existing dwelling and detached garage on Unit 259, Plan 201 0713 within NE-13-26-06-W05M to have a minimum side yard setback of 2.09 metres (6.86 feet), instead of the current required 2.4 metres (7.87 feet). Located approximately 0.20 km (0.13 miles) south of Highway 1A, 0.41 kilometres (0.25 miles) west of Range Road 60, within the CottageClub Ghost Lake Conceptual Scheme.
