#### **DIVISION 3**

Public hearing to consider Bylaw C-8570-2024 to create a site-specific amendment to the Direct Control Bylaw C-6586-2007 (DC-123) to allow the existing Dwelling, Single Detached, and Accessory Building ("lean-to shed") to have minimum side yard setbacks of 2.26 metres (7.41 feet), and 1.42 metres (4.66 feet), respectively, instead of the current minimum requirement of 2.40 metres (7.87 feet). Located approximately 0.41 km (0.25 miles) south of Highway 1A and 0.41 km (0.25 miles) west of Range Road 60, within the CottageClub Ghost Lake Conceptual Scheme.
