## 1 BYLAW C-8575-2024 **DIVISION 4**

Public hearing to consider Bylaw C-8575-2024 to redesignate Lot 1, Plan 8010152 within SE-01-26-03-W05M Residential, Rural Residential District (R-RUR) to Residential, Country Residential District (R-CRD) to accommodate future subdivision of one new lot. Located approximately 3.20 km (1.98 miles) west of the city of Calgary, 0.21 km (0.13 miles) north of Burma Road, and on the west side of Bearspaw Road (Range Road 30).
