Public hearing to consider Bylaw C-8594-2024 to amend Direct Control Bylaw C-4499-1995 (DC-36) on Unit 80, Condominium Plan 0513169 to allow the existing attached deck to have a minimum rear yard setback of 7.83 metres (25.69 ft) instead of the required 8.00 metres (26.25 ft). Located in the Hamlet of Cochrane Lake, approximately 800 metres (0.50 miles) west of Highway 22, immediately east of Monterra Drive, and immediately south of 600 Montclair Place.

A Master Site Development Plan has also been proposed over the subject lands to provide a non-statutory policy framework to guide and evaluate aggregate extraction on the site.
