SCHEDULE A PLANNER:

Scan the QR code to schedule a one-on-one or small group meeting with a County Planner to discuss elements of the plan that matter most to you.



The draft MDP integrates guidance from the current MDP, known as the County Plan (2013), as well as input gathered through our previous stages of engagement. The MDP is an important document that outlines the vision for Rocky View County's future from a planning and development perspective and helps guide how and where the County will grow.

Following Stage 3 Public Engagement, the draft MDP will be finalized and presented to Council at a 2025 Public Hearing later this year.
