### 1 BYLAW C-8633-2025 AND BYLAW C-8634-2025

## Beacon Al Hub Area Structure Plan

Public hearing to further consider Bylaw C-8638-2025 to adopt the Beacon Al Hub Area Structure Plan on Section 11-23-28-W04M (excluding Lot 1, Block 1, Plan 1712088 and Lot 2, Block 1, Plan 2111490), SW-14-23-28-W04M, and SE-14-23-28-W04M to facilitate the development of a data centre campus, with a supporting solar/agrivoltaics facility and other uses complementary to the principal Data Centre use.

## New Land Use District S-DAT (Special, Data Centre District)

Public hearing to further consider Bylaw C-8648-2025 to amend Bylaw C-8000-2020 (Rocky View County Land Use Bylaw) to add a new land use district (Special, Data Centre District). The purpose of this land use district is to provide for the development of data centre facilities and uses complementary to the principal Data Centre use.

## **Redesignation:**

Public hearing to further consider Bylaw C-8645-2025 to redesignate Section 11-23-28-W04M (excluding Lot 1, Block 1, Plan 1712088 and Lot 2, Block 1, Plan 2111490), SW-14-23-28-W04M, and SE-14-23-28-W04M from Direct Control 166 to Special, Data Centre District, including site-specific regulations. Bylaw C-8645-2025 will facilitate the development of a data centre campus, with a supporting solar/agrivoltaics facility and other uses complementary to the principal Data Centre use.

Located approximately 3.2 kilometres (2 miles) east of the city of Calgary and 1.6 kilometres (1 mile) north of the hamlet of Indus.

### 4 BYLAW C-8569-2024

**ALL DIVISIONS** – Public hearing to consider Bylaw C-8569-2024, to amend the Conrich Area Structure Plan to facilitate development within the Future Policy Area. The proposed land use strategy identifies an expanded hamlet area and long-term development area. Located south of Township Road 250 and 0.80 km (0.50 miles) north of Highway 1, and 1.60 km (1 mile) east of the city of Calgary and west of Range Road 282.

- 1. A public hearing will be held at County Hall, 262075 Rocky View Point, Rocky View County, AB, on the dates and times indicated above.
- 2. Anyone who believes they are affected by any of the proposed bylaws noted above will be provided an opportunity to present to Council on the proposed bylaw through one of the methods provided for in Rocky View County's *Procedure Bylaw*.
- 3. The public hearing will be live streamed and a recording will be made available after the meeting.
- 4. To make an in-person presentation, you may attend the public hearing at the date, time, and location indicated on this public notice. If your inperson presentation includes a written or visual component, you must bring at least 15 copies to the public hearing for distribution.
- 5. If you would like to present or provide verbal comments, but are unable to attend the public hearing in-person, you may request to present electronically through Microsoft Teams by emailing <a href="legislativeservices@rockyview.ca">legislativeservices@rockyview.ca</a> no later than noon the day before the public hearing. If you are presenting electronically, you cannot also submit a pre-recorded audio/visual submission.
- 6. You may also submit a pre-recorded audio or video presentation to be played during the public hearing if you are unable to attend the public hearing in-person. Pre-recorded audio or video submissions can be no longer than 5 minutes if you are speaking on behalf of yourself and 10 minutes if you are speaking on behalf of a group. If you have submitted a pre-recorded audio or video presentation, you cannot also present in person or electronically.
- 7. Pre-recorded audio or video presentations must include your name, as well as an indication of where you live in proximity to the subject of the public hearing, preferably in the form of a municipal address or legal land description, as well as the names of anyone you are presenting on behalf of. - 8. In addition to presenting in-person, presenting electronically, or providing a pre-recorded audio or visual presentation, you may make a written submission on the bylaw that affects you. Your written submission must include your name, the applicable bylaw or file number, and an indication of where you live in proximity to the subject of the public hearing, preferably in the form of a municipal address or legal land description.
- 9. Written submissions must be received by the deadline indicated on this public notice. Written submissions received before the indicated deadline will be provided to Council and the public in advance of the public hearing. Written submissions received after the indicated deadline may be accepted and provided to Council at the public hearing if approved through a resolution of Council during the public hearing.
