#### Water and Wastewater Utility Exclusivity Bylaw

A public input session to receive feedback from utility operators on Bylaw C-8662-2025 – Water and Wastewater Exclusivity Bylaw.

#### Important Information

1. A public input session will be held at County Hall, 262075 Rocky View Point, Rocky View County, AB, on the dates and times indicated above.
2. Any utility operator who believes they are affected by the proposed bylaw noted above will be provided an opportunity to present to Council on the proposed bylaw through one of the methods provided for in Rocky View County's *Procedure Bylaw*.
3. The public input session will be live streamed, and a recording will be made available after the meeting.
4. To make an in-person presentation, you may attend the public input session at the date, time, and location indicated on this public notice. If your in-person presentation includes a written or visual component, you must bring at least 15 copies to the public input session for distribution.
5. If you would like to present or provide verbal comments, but are unable to attend the public input session in-person, you may request to present electronically through Microsoft Teams by emailing [legislativeservices@rockyview.ca](mailto:legislativeservices@rockyview.ca) **no later than noon the day before the public input session**. If you are presenting electronically, you cannot also submit a pre-recorded audio/visual submission.
6. You may also submit a pre-recorded audio or video presentation to be played during the public input session if you are unable to attend the public hearing in-person. Pre-recorded audio or video submissions can be no longer than 5 minutes. If you have submitted a pre-recorded audio or video presentation, you cannot also present in person or electronically.
7. Pre-recorded audio or video presentations must include your name and your interest as a utility operator. Pre-recorded audio or video presentations **must be submitted no later than noon the day before the public input session** to the following link: <https://app.box.com/f/f27dcfa5a49e4bfe906aeb9f4c7460d3>
8. In addition to presenting in-person, presenting electronically, or providing a pre-recorded audio or visual presentation, you may make a written submission on the bylaw. Your written submission must include your name, the applicable bylaw number, and your interest as a utility operator.
9. Written submissions must be received by the deadline indicated on this public notice. Written submissions received before the indicated deadline will be provided to Council and the public in advance of the public input session. Written submissions received after the indicated deadline may be accepted and provided to Council at the public input session if approved through a resolution of Council during the public input session.
