#### WHERE TO VOTE

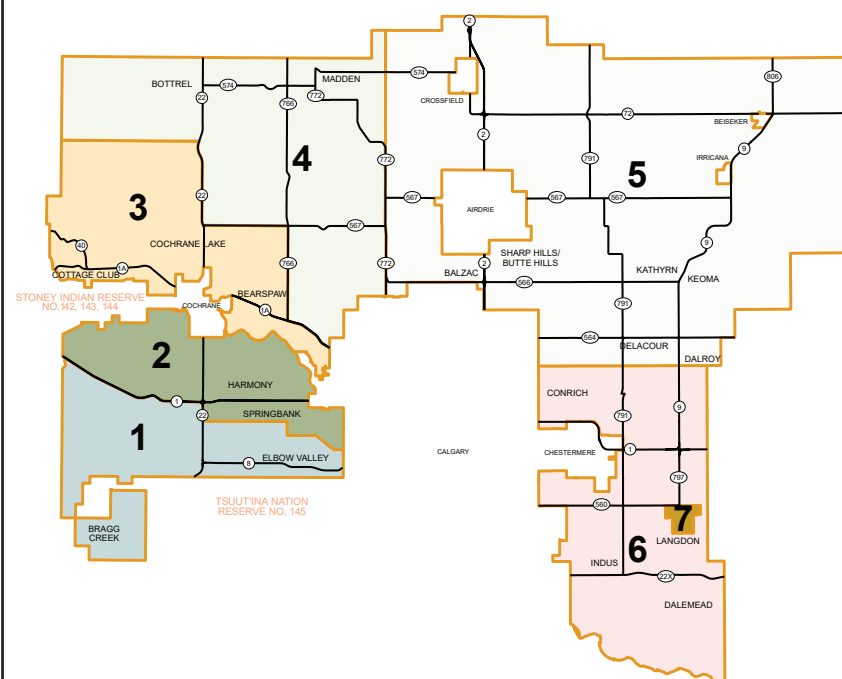
- **Election Day** - Eligible voters may only vote at a voting station within their electoral division
