Unpaid taxes as of the date of termination of participation in the plan will be subject to all penalties as per the Tax Penalty Bylaw C-8358-2023 and a fee of \$35.00 will be charged for any returned payments. I/We acknowledge there may be increases in the amount of the installment payment on June 1st each year as a result of the Rocky View County's annual tax levy. Notification of any changes will be detailed on the property tax notice. The participant will be given 15 days notice before payment amounts are increased for any other reason. I/We acknowledge this agreement may be amended by the 15th of the month preceding the next payment date for different banking information, should the banking information supplied be directed to be changed by either me/us or our bank. Current Levy (\$) ÷ 12 months = Amount of monthly instalment payment (\$)



T.I.P.P. PROGRAM TERMS & CONDITIONS

T.I.P.P. is a monthly tax instalment payment plan by which taxpayers may make consecutive monthly payment for taxes rather than a single annual payment.

How to Enroll for Current Year

- If your tax account is paid in full;
- If you do not presently pay your taxes through a mortgage company (P.I.T.);
- If your application is received by June 15 (final date for late application) accompanied by the missed tax payments for (Jan, Feb & March, Apr, May, June); and
- If the purchaser of a property wishes to assume the existing T.I.P.P. obligations for the purchased property they should immediately contact (403)230-1401 for complete details. **(T.I.P.P payments are non-transferable or refundable)**

Monthly Payments are Calculated as Follows

Your most recent annual tax levy is divided by 12 to establish a monthly payment amount. Payments shall begin January 1 of the new year and continue for 12 consecutive months.

Payment amounts will be adjusted in June to compensate for changes in taxes resulting from the annual tax levy. Your annual tax notice, usually issued in May each year, will show the total amount of instalments paid to date and the calculation of the monthly instalment payment for the remaining payments in that year.

Payments may only be made by automatic withdrawal from a chequing/savings account. You must give written permission before the withdrawal will begin. Rocky View County does not charge for this service; however, normal bank service charges may apply.

If for any reason your property taxes are changed during the year, you will be advised in writing of the new amount of the instalment payment. If your tax instalment increases for any reason other than the annual tax levy, you will be given 15 days' notice before the instalment amount is increased.

Withdrawal/Non-Payment

You may withdraw from the plan by giving notice, in writing, by the 15th day of the month preceding the next payment date.

NOTE: If you withdraw from the plan all penalties in accordance with the Tax Penalty Bylaw C-8358-2023 will be applied to the tax balance unless full payment is received prior to the next payment date or the T.I.P.P. obligations are assumed by another person.

If any payments are not honoured by your bank, a service charge of \$35.00 will be applied. Rocky View County shall cancel the agreement upon default and all unpaid taxes become due and payable and are subject to penalties in accordance with the Tax Penalty Bylaw.

Selling Property/Change of Bank Account

If your property is sold, title transferred, or you have a change in bank accounts, it is the responsibility of the participant to inform the Tax Department in writing. We require the notice of change by the 15th of the month prior to the next T.I.P.P. withdrawal.

How to Enroll for Future Year

Complete and sign the application form, which you can obtain from the County office or the County's website, and return it along with a cheque, marked "VOID" by December 15 to:
