PL20250148 (The Bridge Industrial Park Conceptual Scheme Amendment)

Public hearing to consider Bylaw C-8714-2026, to amend The Bridge Industrial Park Conceptual Scheme, in order to remove the restriction on redesignation from the remaining land (Lots 1-5), increase the total number of industrial lots from 14 to 22, renumber the lot numbers, and update the relevant figures and policies.

Public hearing to consider Bylaw C-8715-2026, to redesignate the remaining ± 9.36 ha (± 23.13 ac) of land (Lots 1-5) within The Bridge Industrial Park Conceptual Scheme from Agricultural, General District (A-GEN) to Industrial, Light District (I-LHT), in order to facilitate the industrial development.

Located within the Conrich Area Structure Plan, approximately 1.6 km (1 mile) east of the city of Calgary, northwest of the junction of Township Road 250 and Range Road 285.

DIVISION 6 – Public hearing to consider Bylaw C-8723-2026 to redesignate a portion of Lot 16, Block B, Plan 731101 within SE-25-23-27-W04M from Residential, Rural District (R-RUR p 4.0) to Residential, Rural District (R-RUR) and Residential, Country Residential (R-CRD) to facilitate future subdivision.

Located approximately 0.81 km (0.50 miles) northeast of the hamlet of Langdon, northwest of the junction of Township Road 234 and Range Road 270.

1. A public hearing will be held at County Hall, 262075 Rocky View Point, Rocky View County, AB, on the dates and times indicated above.
2. Anyone who believes they are affected by any of the proposed bylaws noted above will be provided an opportunity to present to Council on the proposed bylaw through one of the methods provided for in Rocky View County's *Procedure Bylaw*.
3. The public hearing will be live streamed and a recording will be made available after the meeting.
4. To make an in-person presentation, you may attend the public hearing at the date, time, and location indicated on this public notice. If your in-person presentation includes a written or visual component, you must bring at least 15 copies to the public hearing for distribution. **You may pre-register to speak by emailing legislativeservices@rockyview.ca.**
5. If you would like to present or provide verbal comments, but are unable to attend the public hearing in-person, you may request to present electronically through Microsoft Teams by emailing legislativeservices@rockyview.ca **no later than noon the day before the public hearing**. If you are presenting electronically, you cannot also submit a pre-recorded audio/visual submission.
6. You may also submit a pre-recorded audio or video presentation to be played during the public hearing if you are unable to attend the public hearing in-person. Pre-recorded audio or video submissions can be no longer than 5 minutes if you are speaking on behalf of yourself and 10

minutes if you are speaking on behalf of a group. If you have submitted a pre-recorded audio or video presentation, you cannot also present in person or electronically.

7. Pre-recorded audio or video presentations must include your name, as well as an indication of where you live in proximity to the subject of the public hearing, preferably in the form of a municipal address or legal land description, as well as the names of anyone you are presenting on behalf of. 8. In addition to presenting in-person, presenting electronically, or providing a pre-recorded audio or visual presentation, you may make a written submission on the bylaw that affects you. Your written submission must include your name, the applicable bylaw or file number, and an indication of where you live in proximity to the subject of the public hearing, preferably in the form of a municipal address or legal land description.
9. Written submissions must be received by the deadline indicated on this public notice. Written submissions received before the indicated deadline will be provided to Council and the public in advance of the public hearing. Written submissions received after the indicated deadline may be accepted and provided to Council at the public hearing if approved through a resolution of Council during the public hearing.
