Public hearing to consider Bylaw C-8585-2024 for a site-specific amendment to the Direct Control Bylaw C-6586-2007 (DC-123) to allow the existing detached garage on Unit 170, Plan 111 1762 within NE-13-26-06-W05M to have a minimum side yard setback of 2.16 metres (7.09 feet), instead of the current required 2.4 metres (7.87 feet). Located approximately 0.41 km (0.25 miles) south of Highway 1A and 0.41 km (0.25 miles) west of Range Road 60, within the CottageClub Ghost Lake Conceptual Scheme.
