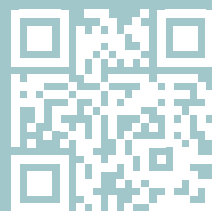
APPLY FOR DISASTER FINANCIAL ASSISTANCE if your home or business experienced flooding damage from July 13 to August 8, 2025.
